TERMS & CONDITIONS

Continuous 10% Credit Bonus to Cash Reward

In order to participate in the Continuous 10% Bonus to Cash Reward promotion you agree to be bound by these terms and conditions as well as the general terms that apply to your account.

10% BONUS PROMOTION Terms and Conditions

1. 10% credit bonus will be issued on new deposit of 1,000 USD and above.
2. 10% credit bonus is for trading purposes only until set amount of lots have been traded; after which credit bonus can be turned into cash.
3. For each new deposit of 1,000 USD that is made a new bonus can be received as long as the bonus amount does not exceed 1,000 USD bonus per account.
4. The client may withdraw funds from their account, but this may result in credit bonus reduction by 10% of the withdrawal amount.
5. Only positions that were open for more than 5 minutes will be eligible for this Promotion.
6. In the event a client deposits more than 10,000 USD then they will be able to maintain 1,000 USD bonus as long as more than 10,000 USD is maintained in the account. Example: Client deposits 10,000 USD and receives 1,000 USD bonus, they later deposit another 5,000 USD to the same account (they do not receive anything as the maximum bonus they can receive in one account is 1,000 USD). The client then withdraws 5,000 USD; they keep 1,000 USD bonus as this correlate to the original 10,000 USD deposit.

7. The bonus will be converted to cash once the required number of lots according to following formula “Credit bonus / 5 = lots to be traded”, have been traded.
8. There is six-month time limit for the lots to be traded.
9. Any withdrawals of profit must be funded to a bank account which matches the GoDo account holder’s name.
10. A maximum of 1,000 USD cash can be issued per account each time the fixed amount of lots has been reached.
11. Traded lots will be calculated on the last working day of every six months from credit bonus. Any applicable cash reward will be deposited into the clients live account within 5 working days.
12. Master accounts and sub-accounts are entitled to this promotion and can receive a maximum of 1,000 USD bonus per account.
13. This revised promotion starts on 1st June 2021 and is on-going.
14. Clients will be informed before this promotion ends and any remaining trading credit is withdrawn.

Communication Delay

GoDo shall not be made liable for any delays in the acceptance or transmission of orders due to a breakdown or failure of transmission or communication facilities, or for any other cause beyond their reasonable control or anticipation.

Disentitlement

In cases of any indiscretion in trading, overleveraging, misuse of orders where “scalping” or “sniping” or “hedging” may be involved, such transactions will not be taken into consideration and will be treated as illegal activity and may even be removed from participants accounts. GoDo reserves the right to disqualify any participant or cancel the trades found in violation of the trading rules or applying inappropriate trading strategies. Scalping defined as trade that was opened and closed within a very short period of time. Hedging means client overexposing his account with an opposite trade to an existing trade with the same trade volume with GoDo or another company to gain profit from deal terms.

Postponement or Cancellation

GoDo in its sole discretion, reserves the right to extend or postpone the promotion periods, to cancel the promotion and/or to reject any participant's application if determined that such action is reasonable and/or necessary.

The credit bonus will be forfeited and removed from the account under the following circumstances:

- The account gets liquidated/stopped out OR
- The account balance becomes negative, and account has no open positions.
- If the equity falls below the credit bonus.

Promotion Terms

GoDo reserves the right to amend or waive any rule during and after this promotion. We may make changes to the Terms and Conditions and will notify you of these changes by posting the modified terms on the GoDo website.
